### DECLARES

[With reference to driving the vehicle (motorcycle) made available to the customer]

1. to be the holder of a valid driving license for road circulation in the territory of the State, to be in possession of the original during the entire duration of the event and to undertake to show it where requested to the personnel in charge by NS45ME or their partners;
2. to be aware that for driving motorcycles with a displacement greater than 50 cc and a power greater than 35 kw (with a power / weight ratio not exceeding 0.2 kW / kw and not derived from a version that develops more than double the maximum power) a type "A" license is required.
3. to be aware that for three years from the driving license issuing date it is not allowed to exceed the speed of 100 km / h for motorways and 80 km / h for main extra-urban roads.
4. [if the client is the holder of a driving license issued by a foreign country]
  - 4.1. that the license enables the driving of vehicles (motorcycles with a displacement greater than 50 cc and a power greater than 35 kw - with a power / weight ratio not exceeding 0.2 kW / kw and which are not derived from a version that develops more than double the maximum power) of the type made available to the customer for participation in the event;
  - 4.2. to be in possession of an international driving license (where required for licenses issued by non-EU countries);
5. to have the technical skills and to be in possession of the psycho-physical conditions required for driving the vehicle on the type of route provided for the event.
6. to have received from NS45ME or their partners, before the start of the event, the information relating to the characteristics of the route necessary for the self-assessment of the adequacy of their technical skills. [In relation to road events]
7. to know the rules governing road traffic in force in the territory of the State (RTA "Regulations for the execution and implementation of the new highway code").
8. to have read and understood the information on the rules of conduct referred to in Annex 1 to this document.
9. to undertake to participate in the pre-event briefing(s) in which the route/track and the main rules of conduct for the prevention of accidents will be illustrated. [In relation to off-road events]
10. to have been informed by NS45ME or their partners about the characteristics and level of complexity of the track and to have the appropriate experience and skills to drive the vehicle safely.



11. to have read and understood the information on the rules of conduct set out in Annex 1 to this document.
12. that NS45ME or their partners have been informed about the characteristics and level of complexity of the track and that they have the experience and skills appropriate to driving the vehicle safely.
13. to undertake to participate in the pre-event briefing(s) in which the route/track and the main rules of conduct for the prevention of accidents will be illustrated. [Assumption of responsibility - sanctions]
14. to comply with the provisions on safety in driving the vehicle provided for by law, by the organizer of the event.
15. to comply with the safety instructions that will be provided by NS45ME, their partners and support pilots.
16. to have been informed and to accept that, in case of violation by the customer of the provisions / indications on safety indicated in the previous points, NS45ME reserves the right to prohibit the customer, with immediate effect, from use of the vehicle for the time it deems necessary to restore safety conditions for the customer and the other participants in the event.
